

## STATUTORY DECLARATION – Currency in leadership/guiding skills

\_\_\_ that I am intending to apply for membership with PACI in the capacity of a leader and am using this document to declare that my formal leadership/guiding skills are current.

\_\_\_ that I understand and accept that venturing outdoors with a group of friends on an informal social activity (eg abseiling or climbing) does not by itself constitute an organised / structured activity where a legal duty of care is owed to others. I realise that such activities do not ordinarily burden one person with leadership responsibilities and expectations to achieve a defined set of group objectives. In consideration of the informal nature of such activities, I further realise that my performance as an individual within the group will not be measured against professional benchmarks established in national leadership standards. I further acknowledge and accept that it would therefore be inappropriate to try to use such activities as a basis for making claims about my capability as a professional leader/guide.

\_\_\_ that I make this declaration in lieu of a properly signed and authenticated logbook record or letter of verification from participants who I was in charge of in an organised and structured activity.

\_\_\_ that I have personally led (and owed a duty of care) a group of participants in an organised activity within the past 12 months.

\_\_\_ that I made decisions at appropriate times to guide/steer the group so that it could achieve its planned activity outcomes

\_\_\_ that I made adjustments to the pace and tempo of the activity to suit individual and group needs

\_\_\_ that I maintained a social atmosphere throughout the activity to ensure everyone enjoyed their participation

\_\_\_ that I was the person in charge of the group and not someone else.

\_\_\_ that I completed all activity objectives/aims within agreed time frames.

\_\_\_ that I made arrangements for logistical support of the activity including such things as travel, equipment needs, communications, nutrition, water, permits to access the activity area and 1<sup>st</sup> aid requirements

\_\_\_ that I was able to deal with conflict within the group and arrive at mutually acceptable solutions

\_\_\_ that it is my responsibility to remain up-to-date with current best practice in the guiding of groups so that I can continuously improve my leadership techniques.

\_\_\_ I further acknowledge that this document may be relied upon in any proceedings instituted in any Court by me or my heirs, executors and assigns or any other natural person.

**I acknowledge that this declaration is true and correct and I make it in the belief that a person making a false declaration is liable to the penalties of perjury.**
